### INTRODUCTION

A summary note is a brief description of a resource. In most formats, it is an optional note under AACR2, but it becomes especially important when contents cannot be easily examined, as in videos, motion pictures, sound recordings, archival collections, and electronic resources. An abstract is more extensive, and can be a stand-alone source of information about the resource. It is a rich source of keywords for electronic retrieval. The two terms are increasingly used together or interchangeably in guidelines for catalogers for use of the MARC tag 520, and the definitions are sometimes merged to allow for more detail and precision in the content of the note.

The quality of summary notes found in online bibliographic records varies greatly, and the audiovisual cataloging community has recently discussed the issue on the OLAC-LIST. In April, 2001, in response to a query, catalogers wrote about their practices in evaluating or creating original summary notes. Responses criticized the use of evaluative or editorial language, "giving away the ending of the story", and poor grammar and spelling. The overall consensus was that catalogers read summaries carefully and edited them if they found them unsuitable. Catalogers cannot rely on commercially produced commentaries or information found on publishers' web sites to accurately and objectively describe any resource. In the future, machine scanning, and use of artificial intelligence for text summarization may be helpful for creation of summary notes, but it is likely that a human interface will still be needed to determine what to say and how to say it and to winnow out inappropriate language.

There are only a few formal instructions for style and content of this note and it is presumed that catalogers would benefit from a comprehensive set of recommendations with examples. AACR2 provides the following advice: Give a brief objective summary of the content of an item [...] unless another part of the description provides enough information (Chapters 2, 4, 6, 7, 8, 9, 10, 11). OCLC Bibliographic Inputs and Standards documentation states that use of the 520 summary note is optional. Its definition combines summary, abstract, annotation, and other types of similar notes. While the note usually uses one subfield, subfield a, USMARC allows subfield b for expansion. There is also provision for a display constant that labels the note Summary, Abstract, or Review. The note can be repeated when there is more than one piece to be described or when it is useful to include summaries in several

languages. The OCLC Internet Cataloging class, now offered online, gives the following recommendation: "Summary/Description (520) The cataloger may provide a concise, objective, free-text description of the resource. This has value for providing both a fuller description of the resource contents and additional free-text subject terms searchable by keyword in many online catalogs. Note: When cataloging the dynamic resource with changing content, a 520 summary note is generally preferable to a formal 505 formatted contents note".

This task force was given the charge of creating a primer of guidelines for writing summary notes and abstracts and providing resources for catalogers to consult in learning how to do this well. Resources available range from cataloging guides for various formats to writing manuals, to web sites for writing news summaries. We present general and format-specific guidelines, examples of existing summaries and some suggested revisions, and a bibliography of resources.

### LITERATURE REVIEW

Prior to developing the guidelines, the task force conducted a literature review to examine existing rules and guidelines concerning the writing of abstracts and summary notes. In doing this, the task force examined the *Anglo-American Cataloguing Rules (AACR2)*, other cataloging manuals based on AACR2, journal articles, the National Information Standards Organization's (NISO) *Guidelines for Abstracts*, books on abstract writing, and various examples of guidelines for abstracts and metadata found on the World Wide Web. The following section summarizes the literature examined in two areas: summary notes and abstracts.

# **Summary Notes**

The *Anglo-American Cataloguing Rules* (*AACR2*) provides little guidance and few examples for creating summary notes. In rule 2.7B17 of AACR2, it states, "Give a brief objective summary of the content of an item unless another part of the description provides enough information." This instruction is repeated for the chapters on different formats, including manuscripts (4.7B17), sound recordings (6.7B17), motion pictures and videorecordings (7.7B17), graphic materials (8.7B17), electronic resources (9.7B17), three-dimensional artefacts and realia (10.7B17), and microforms (11.7B17). In Chapter 9, language is modified to include purpose as well as content of the item. In Chapter 6, it is made clear that the rule is to apply to sound recordings "other than those that consist entirely of or predominantly of music." Rules for summary notes are omitted in Chapter 3 for cartographic materials, Chapter 5 for music, and Chapter 12 for serials. The Library of Congress Overseas Office policy to create "subject notes" for their accession lists provides more extensive guidelines.

More specific guidelines can be found in Saye and Vellucci's *Notes in the Catalog Record*: "1) Make a concise statement, mentioning only major points of the contents. Phrases, rather than sentences, may be used when clarity and good taste permit. 2) Include objective statements only, avoiding any explicit or implicit evaluation of the contents from any point of view. If it is the contents of the works that show a bias, which it is important for the subject note to bring out, word the note carefully so that it is clear the author's bias, not the cataloger's, is the one being related. 3) Depending on the particular contents of a work note that it is important to bring out such information as a) coverage of a time period or of a geographic area; b) educational level or slant of the material, e.g. 'for home study...'or 'college-level instruction...'; c) obvious purpose of the contents; d) genre of the contents, e.g., 'handbook,' 'government report,' 'guidelines'; e) any other major information considered important" (p. 365-366).

Various publications provide examples and more detailed guidance on the creation of summary notes. For instance, Saye and Vellucci (1989) compile the rules and rule interpretations for all formats and provide many examples of summary notes for different kinds of materials. More examples for different formats can be found in *Cataloging of Audiovisual Materials and Other Special Materials* (Olson 1998), which also states the usefulness of summaries as sources of information when assigning subject headings and call numbers. Other publications focusing on the cataloging of specific formats include Rogers and Saye's 1987 *Nonprint Cataloging for Multimedia Collections*, Dodd and Sandberg-Fox's 1985 manual on cataloging computer files, the 1982 *Graphic Materials: Rules for Describing Original Items and Historical Collections*, Fox and Wilkerson's *Introduction to Archival Organization and Description* (1998), Hensen's 1989 manual on archival materials, and Nancy B. Olson's 1991 manual, *Cataloging Motion Pictures and Videorecordings*.

Journal articles have also provided guidance on writing summary notes. With regard to videos, Sheila Intner's 1988 article *Writing summary notes for films and videos* contains a rationale for writing summary notes, in that they permit the browseability of films and videos and promote cost recovery. She recommends sources catalogers may use to write summaries (containers, accompanying materials, reference sources, and acquisition materials), and presents examples of summary notes and evaluations for different genres of films and videos. She also provides guidance for catalogers, both when paraphrasing information from outside sources, and when writing original summaries. Other journal articles include Michael J. Fox's 1990 article on cataloging archival materials, in which he describes the creation of the "Scope and Content/Abstract Note" and Laurel Jizba's 1997 article *Reflections on summarizing and abstracting: implications for Internet web documents and standardized library cataloging databases*. Jizba provides an excellent review of both the cataloging and

abstracting literature, as well as recent developments in the areas of bookseller databases and metadata. She recommends that traditional abstracting and summarization models from different disciplines be examined, along with new database models which employ summary notes (i.e., Borders, Amazon.com). In addition, she recommends the development of uniform content standards for catalogers, web authors, editors, and programmers, and education on the value of summary notes. In the article, she presents the guidance she gives in her Internet cataloging workshops on creating summaries: 1) Answer the What is it? question, 2) Be succinct, use specific wording, avoid full sentences if possible, 3) Describe embedded media, 4) Describe user interaction with action verbs, if possible, 5) Bring out searchable keyword concepts not found in the description or controlled vocabularies, and, 6) Briefly compare outstanding differences with previous formats. Finally, she explores using artificial intelligence and machine scanning applications to extract summary information from Internet documents. Jizba cautions that it remains questionable whether these programs will be able to exercise the kinds of critical thinking skills necessary for creating informative summaries with coherent text that link terms, relate concepts, and provide context for traditional human seekers. Additionally, a report of the CENDI Agency Indexing methods (http://cendi.dtic.mil/publications/98-2index.html) describes use of Machine Aided Indexing (MAI), where finished abstracts are automatically processed to present lists of concepts that can be selected as terms by human indexers.

#### **Abstracts**

There have been numerous books on indexing and abstracting and journal articles that have surveyed the abstracting guidelines in use by database producers. These evaluate guidelines and standards available from different sources. In 1997, the National Information Standards Organization published a revised version of its *Guidelines for* Abstracts (ANSI/NISO Z39.14-1997), intended for abstracts written to accompany a publication, such as a journal article, book, proceeding or technical report. In it, an abstract is defined as "A brief and objective representation of a document or an oral presentation." (p. 1) In addition, it lists the general purpose of abstracts: to enable readers to a) identify the basic content of a document quickly, b) to determine its relevance to their interests, and c) to decide whether they need to read the document in its entirety. In addition, it "facilitates free-text searching in an electronic environment and supports the application of controlled indexing vocabularies in access services." (p. 2) It divides abstracts into two types: informative and indicative. Informative abstracts, used for "documents pertaining to experimental investigations, inquiries or surveys" include purpose, methodology, results and conclusions. Indicative abstracts are used for publications that do not contain methods or results, such as "editorials, essays, opinions, or descriptions; or for lengthy documents, such as books, conference

proceedings, directories, bibliographies, lists, and annual reports." These abstracts, probably the most similar in nature to summary notes in library catalogs, are written to describe the purpose or scope of the contents, and "may describe essential background material, the approaches used, and/or arguments presented in the text." (p. 3) Guidelines are presented for style, length, paragraphing, the general use of complete sentences, first sentences, the use of active verbs, and terminology. An extensive bibliography and list of examples is presented at the end of the *Guidelines*. The *Publication Manual of the American Psychological Association* presents its own abstracting guidelines, which call for statements to be accurate, self-contained, concise, specific, nonevaluative, coherent and readable, to use active rather than passive voice, and to be stated in third person.

Among the several books written on indexing and abstracting, Chowdhury (1999) and Lancaster (1998) in particular provide detailed guidance on writing different kinds of abstracts. Lancaster includes a chapter on indexing and abstracting imaginative works, including works of fiction and feature films.

The task force also examined two studies that surveyed different abstracting guidelines of various database producers. Armstrong and Wheatley's (1997, 1998) surveys examined abstracts found in three types of electronic databases (print-sourced online databases, Internet subject trees or directories, and Internet gateways) and their abstracting guidelines in order to compare quality and content. The researchers concluded that there was little agreement or common standards. They concluded that abstracts do not need to be lengthy in order to be high quality, and that there is a need for different established schools of abstract writing (print sources, gateways, and subject trees) to learn from each other. Meanwhile, an older survey by Fidel (1986) examined the abstracting guidelines used by 123 database producers and found 57 (46%) included instructions for enhancing free text retrieval. With regard to content, all database producers agreed that "important" concepts should be included to facilitate free text retrieval and enhance the subject indexing, and that terms should be coordinated with index terms assigned from a controlled vocabulary. Guidelines varied on the issue of whether to use the exact language of index terms or whether to use natural language terms to complement them. Most guidelines chose concepts to complement descriptors, with the rationale being that access would be improved with a variety of synonyms or more specific terms.

Finally, the task force examined one of the newer "models" described by Jizba: the description element in the Dublin Core element set. According to its guidelines at <a href="http://dublincore.org/documents/2001/04/12/usageguide">http://dublincore.org/documents/2001/04/12/usageguide</a>, the description element is "an account of the content of the resource. Description may include but is not limited to: an abstract, table of contents, reference to a graphical representation of content or

free-text account of the content." It recommends the use of this field when possible, in order to provide a source for indexable vocabulary, and allows metadata providers to take the information from the item itself, if there is no abstract or other structure information available. Jizba has observed that it would be useful to create summary note guidelines for web sites that could apply to both MARC and the Dublin Core element set, as the fields for these two standards may be mapped to each other in both library and Internet databases.

Overall, an examination of the available literature showed that there are few formal guidelines for writing summary notes, and few common abstracting standards used by individual publishers and database producers.

#### GENERAL GUIDELINES FOR ALL FORMATS

The summary note in the MARC bibliographic record provides a brief, concise description of the material in hand. The summary needs to be objective, avoiding any interpretation or evaluation. It is usually best written in phrases rather than complete sentences, using familiar language. The use of slang, colloquial terms or jargon is not advisable. The style should be in active voice and in the present tense. It helps keyword searching and retrieval to include more specific terms, names of people or characters, etc, that are not present in the description, or to include synonyms of controlled vocabularies in the summary note. If the geographical area or time period is known, include that information in the note.

The summary note contains the basic, essential details about the content of the item, such as the nature of item, its point of view, scope, and purpose. This description may also include information which usually would be entered into its own MARC bibliographic tag, such as the audience, educational level, or award. If the inclusion of this information clarifies the summary, use the facts in the summary note instead of in the additional note field. The repetition of information from other parts of the bibliographic record is not necessary.

In addition to these general guidelines, several formats have additional specific characteristics to include in the summary note. The following explores some of these specific characteristics.

# GUIDELINES FOR SPECIFIC TYPES OF MATERIALS AND COLLECTIONS

Motion pictures and videorecordings

- Rewrite the description from the container or accompanying fact sheets in an objective style.
- Remove promotional and emotional language.
- Include essential aspects not mentioned anywhere else in the bibliographic record.
- Include information from other note fields for clarity.
- Include any significant technical or artistic aspects of the production.
- Show the relationship of significant persons to the work if this connection is not clear from the rest of the description.
- Identify the genre and target audience as appropriate.

## **Graphic materials**

- Provide an objective note describing the object.
- Explain in more detail the general material designation, or the specific material designation in the physical description.
- Include the type of material, medium and style.
- Include the significant persons, events, places and dates related to the item.

#### **Electronic resources**

- Take the note information from the material, its introduction or first few paragraphs.
- Write the summary in a non-evaluative style.
- Include the interaction of the user with the program.
- Mention any specific effects, such as laser display or animation, used to convey the information.
- For those computer files only understood by computer software, write a brief, concise description of the purpose of the file.

# Specific guidelines for web sites (in addition to those above)

- Include a brief statement about the other sites connected to the main page.
- Describe any unique features of the original site.
- Show how the user interacts with the web site.

• Include the interaction of the components mentioned in the physical description as the items relate to context of the whole item.

# **Sound recordings**

- Exclude the summary note for those recordings that are solely musical.
- For nonmusical sound recordings, retrieve summary note information from the cassette or any accompanying description.
- Include any unique or artistic characteristics in the summary note.
- Explain the relationship of the artists or authors to the contents if not clear from the rest of the description.

# Content

- List specific types and forms of materials present.
- Provide the most important information for the collection.
- Describe the reason and function of the collection.
- Include the significant people, places and events, and topics covered.
- Include the span of dates covered by the collection even if they are approximations.
- Describe the consequences, products and results of the events documented.
- Present the typical and unique characteristics of the collection
- If creating a summary note for one item, describe the item, its nature, scope, and purpose.

### **CONCLUSION**

These suggested guidelines represent an effort to bring consensus to the How? What? When? And Who? questions that need to be answered to create a description of materials that is both efficient for catalogers and useful for patrons. It is essential to provide as much information as possible, yet not overwhelm the researcher trying to decide the appropriateness of the materials. Since the 520 summary note is keyword searchable, it can not only form the basis for the formulation of subject headings and call numbers, but it can bring out keyword concepts for which adequate subject headings have not yet been established. In her article Reflections on summarizing and abstracting: implications for Internet web documents and standardized library cataloging databases, Laurel Jizba argues that natural language summaries will increase in usefulness as more and more materials are made available online and on the Internet. Indeed, contents of summaries and abstracts can provide keywords for smart retrieval by search engines as well as researchers.

The Task Force hopes that this document will help streamline the process of creating and evaluating summary notes and thus increase their use, and that catalogers will be

active in educating information providers about the importance of well written summaries and abstracts. It is our intention that this report can serve as a springboard for further discussion and evaluation.
