Throughout my academic career I always thought research was a very scientific process which included test tubes, measurements, papers upon papers, and lab coats. However, my opinion has greatly changed and become more accurate throughout college. The Honors program has allowed me to gain a better understanding of how to complete research.

My journey to an accurate research knowledge began when I took my Honors First Year Experience class. I began to understand the roles of information literacy and information synthesis. At first I struggled with finding resources for my papers. When completing my research essay for the class, I improved my methodology of effectively, efficiently, and critically accessing information as well as organizing others' ideas. I accessed various academic databases online to search for resources. In this class I learned that research is proposing a question and the process of seeking the answer to that question.

The following semester I continued to grow my information literacy and synthesis skills in my English composition class. Since I already had a foundation started from my Honors First Year Seminar, writing my papers was much easier since I already knew how to access information. Through writing my proposal I not only demonstrated how to ethically use information but also to incorporate selected information into my knowledge base. Through my response I was able to synthesize diverse perspectives to the topic.

As a student majoring in statistics, research had a strong presence in my upper-level courses. Most of the courses taught various methods on how to ethically research data specifically though the use of datasets. I learned how to create predictive models such as regression models in STAT450: Regression Analysis and linear regression in STAT458: Categorical Analysis. My STAT492: Capstone class tied all my knowledge from previous classes together through a final project where I analyzed a dataset on pet adoption at Petfinder.my. I was able to exemplify various statistical methods as well as complete original research. The skill of incorporating selected information was essential to synthesizing my research to key information and then relating that to advise how to use this knowledge to improve methods.

After gaining some experience in my statistic courses, I was able to apply my research knowledge through hackathons. A hackathon is a data analytic competition where a dataset is given by a data sponsor and teams analyze the data to give business solutions to the sponsor through a presentation and paper. I completed in a total of five hackathons. At these I worked with others to complete original research and disseminate our results. These competitions helped me understand that research in my field is analyzing given data for meaningful answers to business-oriented questions. We won honorable mention at the datathon at Advanced IT 2017, 2nd place Data Visualization Award at MUDAC in 2019, 1st Place in the Advance category at Data Derby 2019, 1st place in the advance category Datagon at Data Derby 2019. Through these hackathons, I was able to fully develop my research abilities through information synthesis, information literacy, original research, and dissemination of results.

Upon graduation in the winter, I will start my career as a data analyst. As a data analyst I will be researching constantly for businesses. I am very thankful for my undergraduate classes as well as the Honors program for allowing me to not only learn what it means to complete research but also giving me opportunities to apply my research skills. Throughout my career I hope to continue to grow and master research by continuing to learn every day.

Before attending MNSU, I had no clue what it meant to be a Global Citizen. My first guess would be it is another term for a world traveler, but that is completely wrong. Throughout my academic career, I was able to learn what it means to be a global citizen as well as evolve in the three aspects of global citizenship: self-awareness, knowledge, and communication.

After completely forgetting two years of Spanish classes in high school, I restarted learning a second language by completing Spanish 101: Elementary Spanish. This course allowed me to verbally and nonverbally communicate in basic, familiar situations through various vocabulary, grammar, writing, and oral Spanish activities. The following year I continued to develop my Spanish abilities in Spanish 102: Elementary Spanish II, where I identified the connection between language and culture. My last semester of college I finished my language requirement by taking Spanish 201: Intermediate Spanish. Being able to communicate effectively with others is an essential skill to success. Knowing a second language allows me to successfully communicate and work with a wider range of people.

My senior year I worked as a server at Buffalo Wild wings where I was able to demonstrate my Spanish speaking abilities outside of the classroom. I would have a lot of customers whose first language was Spanish. Because of my previous three Spanish classes, I was able to communicate in Spanish well enough to learn their food order and other basic dining conversations. At first, these situations were uncomfortable, but they made me realize how uncomfortable I was trying to use my Spanish. I hoped to continue learning Spanish for situations like this to make communication easier for all parties involved.

Since I was learning Spanish, I wanted to grow in my knowledge of Spanish speaking people and their cultures. I took Ethics 204W: Perspective on Latino/Hispanic Diversity. Through weekly discussions, book readings, videos, and papers I was able to ask questions that showed an increased understanding of complex cultural practices, products, and perspective to the Latino/Hispanic Culture. I recognized new perspectives about other cultures and compared and contrasted that to my own.

In my daily life I was also growing accustomed to many different cultures besides those of Spanish speakers. When I was the Personal Relations chair to D.R.E.A.M. (Data Resources for Eager, Analytical Minds), I not only grew in my self-awareness but also knowledge of other cultures. This student club has many members from a variety of different nationalities. Through conversations with these members I grew in my knowledge and by attending meetings I was able to perceive myself as a member of my own culture. Also, through my statistic courses, roommates, and swimming I was able to continue to develop my self-awareness and hone my understanding of my culture and the communities of which I am a part. Through conversations with multiple different diverse individuals, I was able to grow in my knowledge of other cultures.
