RESEARCH

Research allows people to gain further knowledge on the world and how it functions. Two essential skills in the realm of research are conducting original research and ethically integrating others' findings with your own ideas. I have gotten the opportunity to develop my understanding of the research process and find techniques that fit into my areas of interest. Overall, I have come to view research in the aspects of accumulation of background knowledge, methodology, and sharing conclusions.

Accumulating and understanding knowledge of past research is essential to doing quality research. Two experiences in which I have been able to synthesize other's research in with my own ideas are an **essay** I wrote on Stuart Davis and my **narrative journalism** essay. In these pieces, I was able to access scholarly sources, conduct in person interviews, reflect on my personal opinions, and synthesize information to support my arguments. While writing both essays, it was important to evaluate the credibility of sources to increase the credibility within my writing. With the collection of background information being the first step in research, it is important that this step is executed effectively and efficiently.

Once the researcher has an idea of the past findings on the subject matter, research can be conducted. Making sure that the methodology of research is fully planned out is important for the quality of the project. One project in which I focused on customizing the methodology to my objectives is in my **honors 401 research proposal**. The way I proposed to collect data for this project was to conduct before and after surveys of first-generation college students attending orientation. While writing this proposal, I realized that the methods you use in your study are customizable based on the subject of your study, the objectives of your study, and your audience. Before college, I always viewed research as the stereotypical scientist testing rats in a lab, which never interested me. Having my own research experiences has helped me realize that research is anything you want it to be and anything that interests you.

Research has lots of steps and barriers that one must face before being able to draw conclusions from their data. Although some may view the conclusion as the most exciting part, it is the things that led you to the conclusion that makes the experience significant. This proved true within the **critical thinking** study I worked on with a faculty advisor. I learned a lot about the research process by pushing myself out of my comfort zone and immersing myself in this research project. Writing a proposal for this project showed me how I can effectively present information and conclusions to people who have never heard of the project by telling them why it is important to them and why they should care. Writing the research proposal and presenting this project at the Undergraduate Research Symposium has been a fun and unique experience for me. Due to COVID-19 it has taught me how to be adaptable to any situation and preserve through any challenges that come my way. Also, it has still allowed me to understand how to create an effective research poster that will catch the eye of the general public and give information catered to my audience while showing my conclusions.

Research is something that will be prevalent within my daily life, academic career, and occupation within the student affairs field. I hope to always push myself further within my knowledge and create breakthroughs within the field of student affairs in learning how to better serve students. The experiences I have had with research in my undergraduate career have opened up a wide range of opportunities to pursue research further in an efficient, ethical and unique manner.

GLOBAL CITIZENSHIP

Individuals have the opportunity to see the world from their own eyes, gain knowledge through their experiences, and hear stories from the second they enter this world. These experiences contribute to one's perspective of the world, but what makes someone a global citizen? What truly helps someone understand a part of the world that they have not been exposed to yet? These are questions that I asked in the beginning of my time in the Honors Program at Minnesota State University, Mankato. My undergraduate experience has helped me gain a deeper understanding of the world and people who hold different experiences, perspectives, and identities than myself.

Self-awareness and open-mindedness are two qualities of a good global citizen. Taking time to evaluate one's own role in a cultural society, while also being able to ask questions about the less familiar things is a good starting point to developing one's cultural competence. I started to reflect on my identities, privileges, and biases when writing my **Global Citizenship Essay**. Being able to recognize more about myself in a increasingly global society motivated me to understand people and experiences to which I had not been exposed.

Another quality that enhances global citizenship is curiosity. As I became curious about other peoples' stories, I got involved in the **Language Partners Program**. This experience allowed me to hear about the cultural norms that people experience in other areas of the world and how that differs from my home. It taught me about the highs and lows of acclimating to another culture and immersing oneself in a completely unfamiliar place.

Being vulnerable plays a big role in understanding something that you don't know. One instance in which I was vulnerable was holding an event about privileges and identities on my floor as a community advisor. **Paint a Stroke** was an eye-opening event when thinking about my views on societal norms and how those differed from my residents. This challenged me to ask myself why I had perceptions of my residents that may not have aligned with their true values. This realization allowed me to open my heart and my mind to my residents so that I could get to know them for who they really are, not what my personal biases or experiences indicated.

Increasing global awareness and understanding comes with vulnerability. Learning the French Language in **French**201 made me vulnerable. This class taught me the norms of verbal and nonverbal communication in French while challenging myself to compare and contrast French culture to my own. This challenged me greatly while learning sentence structure, articulation, and cultural vocabulary. As I gained these communication skills, I pushed myself to the next level by performing a French Poem called Nuits De Juin at a **Poetry Recital**. This was an unfamiliar situation as it was on a stage and in front of many students and faculty that I did not know. I did my best to perform this poem in a culturally appropriate manner. My goal was to embrace the culture and authenticity of the poem when performing.

A rewarding aspect of cultural competence is being able to communicate and understand people from other regions and identities. Having a **foreign exchange student from France** on my floor and helping her through the process of being in the United States for the first time was a great experience. Being able to communicate with her in French allowed me to understand more about the French culture and how she has developed into the young woman that she is now. Overall, embracing unfamiliar experiences and cultures helps one learn about themselves and the world around them on a deeper level. While striving to be a student affairs professional, the skills and values that I have learned in this experience will allow me to better serve students of various identities.
